This is when the state took me from my family, and put me in a foster home.

I was taken from my home and the Department of Health and Human Resources people said that I couldn't live with any of my family members. I did some bad things and was taken to juvie. I had decided since I was homeless, I didn't have anything to lose. That is why I did what I did to get locked up.

I was in foster care but then a cop came to the house and I told him that he was not in his jurisdiction. The reason why I told him that is because he tried taking me from the foster home.
