1. The Plaintiff, Commonwealth of Massachusetts, brings this complaint for forfeiture in the nature of a proceeding in rem.
2. The Defendant, Two Thousand One Hundred Twenty One Dollars (\$2,121.00) in United States Currency are moneys seized pursuant to arrests involving controlled substances by the Sturbridge Police Department.
3. On December 31, 2011, the Sturbridge Police Department arrested [REDACTED] h [REDACTED] r [REDACTED], DOB: 07/01/1985 for violations of the controlled substance act and seized the amount of \$433.00 in United States Currency.

13. On February 12, 2016, the Sturbridge Police Department arrested ██████████ y ██████████ n ██████████, ██████████, DOB: 07/27/1985 for violations of the controlled substance act and seized the amount of \$200.00 in United States Currency.

14. The defendant was used or intended for use in the procurement, manufacturing, compounding, processing, delivery, and distribution of controlled substances or were the proceeds of the sale of controlled substances, all in violation of G.L. c. 94C.

WHEREFORE, the plaintiff prays:


a) That this Court issue notice to the following individuals:


